

ARTICLES OF INCORPORATION

OF

MO-KAN COUNCIL OF AMATEUR RADIO CLUBS, INC.

The undersigned, natural persons of the age of eighteen years or more, for the purpose of forming a not-for-profit corporation under The General Not-For-Profit Corporation Law of Missouri, hereby adopt the following Articles of Incorporation:

FIRST: The name of the corporation is: MO-KAN Council of Amateur Radio Clubs, Inc.

SECOND: The address of its initial registered office in the State of Missouri is 7000 N.E. 120th, Kansas City, MO 64166 and the name of its initial registered agent at such address is Lyndell C. Miller.

THIRD: the names and places of residence of the incorporators are: Lyndell C. Miller, 7000 N.E. 120th, Kansas City, Missouri 64166; Kenneth C. Yarnevich, 3010 N. 70th Terrace, Kansas City, Kansas 66109; Vernie L. Ellis, 2900 S. 25th St., Kansas City, Kansas 66106; and W. Neill Clendenin, 6619 Ballentine Ave., Shawnee, Kansas 66203.

FOURTH: The number of the Directors to constitute the initial Board of Directors shall be four and said initial Board members shall be the individual incorporators as named and at the addresses shown in ARTICLE THIRD above. Thereafter, the number (not less than three) of Directors to constitute the Board shall be fixed or determined by the Bylaws of the Corporation, and any change in said number, as provided in said Bylaws, shall be reported to the Secretary of State within thirty calendar days of such change.

FIFTH: The duration of the corporation is perpetual.

SIXTH: This corporation is formed for the following purposes:

(a) To provide educational and scientific facilitation and assistance in the (1) management of amateur radio activities, (2) frequency coordination services for amateur radio repeater stations, (3) exchange of amateur radio information between amateur

radio clubs, associations, and individuals, (4) promotion of cooperation between member organizations and the general public, (5) providing of community service through usage of amateur radio and (6) to directly engage in the foregoing enumerated activities.

(b) To carry on, transact and engage in any and every lawful act or activity for which a corporation may be organized under The Not-For-Profit Corporation Law of Missouri, anywhere within or without the State of Missouri, regardless of whether such act, business or activity is related to or useful in connection with the purposes described in (a) above; and

(c) To have and to exercise each and all of the powers and privileges, either direct or incidental, which are given and provided by or are available under the laws of the State of Missouri (as now or hereafter in effect) in respect of corporations organized under the Not-For-Profit Corporation Law of Missouri.

SEVENTH: No contact or other transaction between this corporation and any other firm, association or corporation shall be affected or invalidated by reason of the fact that any of the directors or officers of this corporation are interested in or are members, shareholders, directors or officers of such other firm, association or corporation; and any director or officer of this corporation may be a party to or may be interested in any contract or transaction of this corporation or in which this corporation is interested, and on such contract shall be affected or invalidated thereby; provided that such contract or transaction is entered into in good faith and authorized or ratified on behalf of this corporation by the board of directors or by a person or persons (other than the contracting person) having authority to do so, and if the directors or other person or persons so authorizing or ratifying shall then be aware of the interest of such contracting person.

EIGHTH: The board of directors shall have the power to make, alter, amend or repeal the Bylaws of the corporation.

NINTH: The corporation reserves the right at any time and from time to time to amend, alter, change or repeal any provisions contained

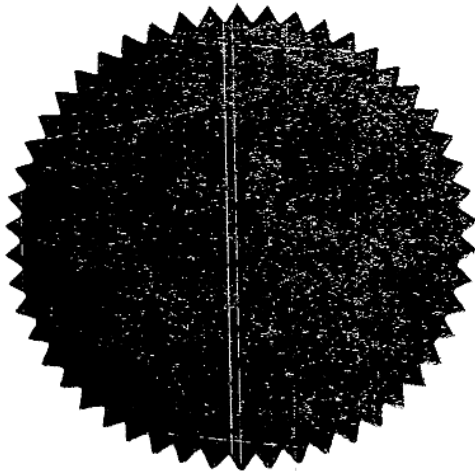
